Privacy Policy (dated May 25, 2018)

Your privacy is important to us at Together Rising. This Privacy Statement is meant to help you understand what data we collect, why we collect it, what we do with it, and the choices available to you when using any of our websites, tests, products, or other services. We will not use or share your information with anyone except as described in this Privacy Policy. This Privacy Policy does not apply to information we collect by other means (including offline) or from other sources.

Information We Collect

User-Provided Information: You provide us information about yourself, such as your name and e-mail address, if you donate to Together Rising, contact us via email, fill out a form (e.g., to become a volunteer, request assistance or to fundraiser for Together Rising), or connect with our social media (including by “following,” “liking,” linking your account to TogetherRising.org, etc., on a third party website or network). If you correspond with us by email or through populating a form on our website’s domain, we may retain the content of your email messages or responses.

Cookies

At Together Rising, the security of your information and the experience you have when visiting our websites is important to us. We use cookies and similar technologies to assist us in these areas. For example, these technologies are used for storing and processing preferences and settings and capturing information about how our websites and emails are used. We may also use information collected through automated technologies on our websites and emails for interest based advertising. You may limit how we and our service providers utilize these technologies through your browser settings or by visiting sites that provide interest based advertising, as described more fully below.

If you are accessing our websites from the European Union and certain other countries, you will be presented with an additional opportunity to accept or block the use of cookies. You may block the use of certain cookies via your browser; however, this may limit your use of our services and products.

Analytics

Similar to many websites, Together Rising works with service providers to enhance and improve our websites, products, and services. These providers supply tools for traffic monitoring, interest-based advertising, surveys, social media advertising, and email marketing. Together Rising uses Google Analytics for this purpose. Together Rising monitors site traffic and technical performance to administer our websites, to improve our visitors’ experiences, evaluate site usage, and provide site security. Responding to Do Not Track Signals

Some browsers provide the ability to send a Do Not Track signal to websites. Our websites do not respond to these signals or similar mechanisms.

How We Use Your Information

We use the personal information you submit to operate, maintain, and provide to you the features and functionality of TogetherRising.org.

By providing Together Rising your email address (including by “following,” “liking,” linking your account to TogetherRising.org, on a third party website or network), you consent to our using the email address to send you Together Rising-related notices, including any notices required by law. You also agree that we may send you notifications of activity on TogetherRising.org to the email address you give us, in accordance with any applicable privacy settings. We may use your email address to send you other messages containing relevant information, such as newsletters, changes to features of TogetherRising.org, or other information related to requests that you submit to our email account. If you do not want to receive such email messages, you may opt by unsubscribing through the link provided on the email or by contacting us at contact@togetherrising.org.

Together Rising reserves the right, but has no obligation, to monitor the user content you post on TogetherRising.org and any of our social media sites. We reserve the right to remove any such information or material for any reason or no reason, including without limitation if in our sole opinion such information or material violates, or may violate, any applicable law or to protect or defend our rights or property or those of any third party. Together Rising also reserves the right to remove information upon the request of any third party.

How We Share Your Information

Personal Information: Together Rising will not rent or sell your personal information to others. Together Rising may share your personal information with third parties for the purpose of providing Together Rising services to you. If we do this, such third parties’ use of your information will be bound by this Privacy Policy. We may store personal information in locations outside the direct control of Together Rising (for instance, on servers or databases co-located with hosting providers).

Any personal information or content that you voluntarily disclose for posting to TogetherRising.org or our social media sites, or that you affirmatively consent to make public, becomes available to the public, as controlled by any applicable privacy or website customization settings. If you remove information that you posted to TogetherRising.org or our social media sites, copies may remain viewable in cached and archived pages, or if other users have copied or saved that information.

Except as otherwise described in this Privacy Policy, Together Rising will not disclose personal information to any third party unless required to do so by law or subpoena or if we believe that such action is necessary to (a) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (b) to enforce this policy, take precautions against liability, to investigate and defend ourselves against any third-party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (c) to exercise or protect the rights, property, or personal safety of Together Rising, our users or others.

How We Protect Your Information

Together Rising cares about the integrity and security of your personal information and takes reasonable safeguards to maintain that security. We cannot, however, ensure or warrant the security of any information you transmit to Together Rising or guarantee that your information on the service may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards. Your privacy settings may also be affected by changes to the functionality of third-party providers, such as social networks. Together Rising is not responsible for the functionality or security measures of any third party.

Your Choices About Your Information

You may, of course, decline to submit personal information through Together Rising in connection with your request to become a volunteer or to receive assistance, in which case Together Rising may not be able to provide certain services to you. Children's Privacy

Protecting the privacy of young children is especially important. For that reason, Together Rising does not knowingly collect or solicit personal information from anyone under the age of 16. In the event that we learn that we have collected personal information from a child under age 16 without verification of parental consent, we will delete that information as quickly as possible. We reserve the right to determine the form and means of providing notifications to you, provided that you may opt out of certain means of notification as described in this Privacy Policy.
