THE BOARD VOTED TO APPROVE A TOTAL OF \$4,135,430 IN GRANTS.

IN MARCH, TOGETHER RISING ACCOMPANIED 29 FAMILIES PRESENTING AT THE U.S./MEXICO BORDER TO BE REUNITED WITH THEIR CHILDREN WHO WERE TAKEN FROM THEM WHILE LEGALLY PRESENTING THEMSELVES TO SEEK ASYLUM. THIS REUNIFICATION HAD BEEN ORDERED BY FEDERAL COURTS IN THE UNITED STATES, BUT THE FEDERAL GOVERNMENT WAS UNABLE TO LOCATE THESE FAMILIES IN ORDER TO FULFILL THE COURT ORDER. THEREFORE, TOGETHER RISING FUNDED AL OTRO LADO IN THE AMOUNT OF \$375,000 TO HELP (CONTINUED ON SCHEDULE O)
